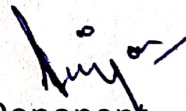
1. That Bal Vatika Educational Society, Fatehabad is registered society under the Act 21 of 1980 (Name of the under which Society/Trust is registered/ section).

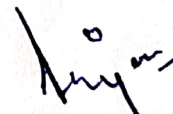

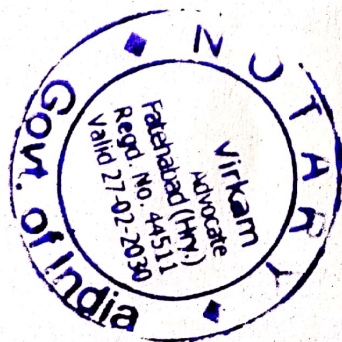
10. That the school will ensure the sufficient number of qualified teachers as per the provision contained in affiliation by-law are available with the school before starting classes.
